




#### What is the sequence of events in the criminal justice system?



This chart seeks to present a simple yet comprehensive view of the movement of cases through the criminal justice system. Procedures in individual jurisdictions may vary from the pattern shown here. The differing weights of line indicate the relative volumes of cases disposed of at various points in the system, but this is only suggestive since no nationwide data of this sort exists.





  - Screening Agencies Discharging Individuals if UA+
  - Responsiveness to Families, Guardians & Law Enforcement
  - Communication about FU
  - Understanding of "DTS/DTO"
- BHPs Calling "911" or Evicting Individuals for Behaviors
- Individuals Living with Chronic Mental Illness: Homelessness; Inadequate Beds & Settings



## ARIZONA FELONY CONVICTION: A LIFETIME GAME CHANGER

- Tough Criminal Code w/ Long Sentences
- Sentencing By Chart; Minimal Judicial Discretion.
- Mental Disorder is NOT A Defense to Committing a Crime
  - GEI not NGRI.
  - ASH not prison. Or both.
- Collateral Consequences
  - Registration & Probation Domestic Violence; Sex Offenses
  - Suspended Civil Rights for Felonies
  - Set Aside; No Expungement.

### MISDEMEANOR ASSAULT – A.R.S. §13-1203

A person commits assault by:

- 1. Intentionally, knowingly or recklessly causing any physical injury to another person; or
- 2. Intentionally placing another person in reasonable apprehension of imminent physical injury; or
- 3. Knowingly touching another person with the intent to injure, insult or provoke such person.

# AGGRAVATED ASSAULT – A.R.S. § 13-1204 Class 2-5 Felony

13- §1203 Assault + any of 11 items & sub-items What – Serious Injury, Etc.

Who - Peace Officers; Correctional Officers; Etc.


(e) A health care practitioner who is certified or licensed pursuant to title 32, chapter 13, 15, 17 or 25, 1 or a person summoned and directed by the licensed health care practitioner while engaged in the person's professional duties. This subdivision does not apply if the person who commits the assault is seriously mentally ill, as defined in §36-550, or is afflicted with alzheimer's disease or related dementia."

**Where** - Jail or Corrections, Etc.

What Else – Weapons, Simulated Weapon, Item of the Officer.

### UPON ARREST 3 THINGS TO NEVER DO

- RUN.
  - You won't make it.
  - You Add Charges.
  - You Look Guilty.
- Touch An Officer.
  - OR Spit, Throw Water, Or Kick Dirt, Etc., Etc.,
- Interfere In An Arrest
  - In any way whatsoever.

  - Contact Your Attorney.










#### DIVERSION AND DEFERMENT PROGRAMS

- ARS § 11-361 AZ County Attorneys have sole discretion to <u>divert</u> or <u>defer</u> prosecution.
   (Elections matter)
- Maricopa County
  - Drug Diversion + Felony Pre-Trial Intervention Program (FPIP) NOW COMBINED
    - FPIP Post Charging; CBT; F4 –F6; Minimal Criminal History; Low Risk to Reoffend
  - Justice Court Diversion Post-Charging
- Yavapai County Sheila Polk's Remarkable Program
  - Nexus to substance abuse
- Coconino County –CBT; Deferred Prosecution
- Pima County- DTAP; Felony Drug Diversion; Adult Diversion

### RULE 11 – Competency and Competency Restoration

- ISSUE: Is the Defendant able to understand the nature of the proceeding being brought against him and to assist in his defense?
  - Can happen at any time in proceedings ("Competency is transient.")
- Motion by Prosecutor or Defense Counsel to Transfer Case to Rule 11 Court
- 2 Experts Appointed Forensic Services "List"
  - Reports Confidential/Under Seal
  - But Discoverable for GEI



- No Restorable?
- Maybe ("Tie") Tie Breaker Evaluator
- Not Competent -> "Competency Restoration"
  - In Custody RTC Program run by CHS
  - Out of Custody Outpatient Treatment Plan w/ Status Report

#### Not Restorable

- Order Title 36 Petition for COT be Filed
- Order Title 14 Petition for Guardianship and/or Conservatorship Be Filed
- Order Released & Charges to Dismissed Without Prejudice

### MITIGATION OF SENTENCES: A.R.S. § 13-701


- Sentencing By Chart Mitigation Can Move Within a Box & Determine Concurrent or Consecutive Sentences.
- Sentencing judge must consider:
  - Age
  - Capacity to appreciate wrongfulness of the conduct or to conform conduct to the requirements of law was significantly impaired
  - Under unusual or substantial duress
  - Minor participation in the crime.
  - Compliance with duties imposed in A.R.S. 28-661, 28-662 and 28-663.
  - "Any other factor that is relevant to the defendant's character or background or to the nature or circumstances of the crime and that the court finds to be mitigating."

## AGGRAVATION OF SENTENCES: A.R.S. § 13-701


- Oversimplified Explanation Of 27 Complicated Factors
  - DEFENDANT'S CHARACTERISTICS: Felon; Fiduciary; Hired; etc.
  - **DEFENDANT'S TOOLS**: Mask; Body Armor; Weapons; Surprise; etc.
  - VICTIM CHARACTERISTICS: Elderly, Police Officer, Family of Decedent, etc.
  - NATURE OF CRIME Trafficking; Intentional Pain/Suffering; Hate Crimes, etc.
- "Other circumstances that the court deems pertinent based on the defendant's character, history, or other relevant facts"






